(3) every attempt by any person foreign to the Lockhart Patriarchal Trust to supersede or undermine or interfere with or in any way violate the Power of Attorney of the Dominion of Byron over any person within the jurisdiction of the Lockhart Patriarchal Trust constitutes a trespass against the Lockhart Patriarchal Trust by which such foreign person is entered into the jurisdiction of the Lockhart Patriarchal Trust, and consent to be so entered, thereby ceding Power of Attorney over such foreign person to the Dominion of Byron until such trespass is remedied to the satisfaction of the Dominion of Byron;


(6) every person within the jurisdiction of the Lockhart Patriarchal Trust is forbidden to enter into any security agreement with anyone foreign to the jurisdiction of the Lockhart Patriarchal Trust whereby any body of any natural person within the jurisdiction of the Lockhart Patriarchal Trust may be held as collateral;

(7) the Dominion of Byron hereby fully indemnifies any and every such security agreement;

- (8) as, per such indemnification, first secured party creditor over any and every such security agreement, the Dominion of Byron hereby reserves all rights to any and all collateral for any and every such security agreement, including but not limited to any and every body that may be held as collateral for any such security agreement;
- (9) in accordance with such rights, the Dominion of Byron will charge any one who takes or holds custody of any such body as collateral for any such security agreement, or who detains any body within the jurisdiction of the Lockhart Patriarchal Trust for any reason, \$1000000 for every hour that any such body as collateral is so held in custody or any such body within such jurisdiction is so detained;
- (10) failure of any, foreign to the Lockhart Patriarchal Trust, person charged as stipulated herein or pursuant to any contract with or trespass against the Dominion of Byron to pay such charge to the Dominion of Byron immediately on demand of any Agent Trustee of the Dominion of Byron constitutes a trespass against the Lockhart Patriarchal Trust by which such foreign person is immediately entered into the jurisdiction of the Lockhart Patriarchal Trust, and consent to be so entered, thereby ceding Power of Attorney over such foreign person to the Dominion of Byron until such trespass is remedied to the satisfaction of the Dominion of Byron;
- (11) every entry of any person into the jurisdiction of the Lockhart Patriarchal Trust by way of trespass by such person against the Lockhart Patriarchal Trust constitutes a security agreement between the Dominion of Byron as secured party and such person as debtor to such secured party whereby such person pledges any and all property of such person as collateral to secure the obligation of such person to remedy such trespass to the satisfaction of the Dominion of Byron, and so grants to the Dominion of Byron a lien on all of such property, with unlimited rights pertaining to all of such property;
- (12) The Expressly Claimed Persons and The Expressly Claimed Names may be amended by the Dominion of Byron as additional persons or names come into the jurisdiction of the Lockhart Patriarchal Trust, but every omission, and every failure to notify, of any such amendment does not prejudice any right of the Dominion of Byron;
